ARTICLE I NAME

The name of the corporation is KENNESAW STATE UNIVERSITY RESEARCH AND SERVICE FOUNDATION, INC.

ARTICLE II NONPROFIT STATUS

The corporation shall be a nonprofit corporation, which is organized pursuant to the Georgia Nonprofit Corporation Code; and the corporation shall have no capital stock and no shareholders. The corporation shall have no members.

ARTICLE III PERIOD OF DURATION

The corporation shall have perpetual duration.

ARTICLE IV PURPOSES AND POWERS

The corporation is organized and shall be operated exclusively for scientific, scholarly,

stimulate and promote further research, public service, creative pursuits, and education;

Kennesaw State University, shall be a member ex officio, and shall have full voting power: The Vice President for Business and Finance of Kennesaw State University shall (2) be a member ex officio and shall have full voting power; The Vice President for Development and University Relations of Kennesaw State

University shall be a member ex officio and shall have full voting power;

- (4) The Dean of Graduate Studies of Kennesaw State University shall be a member ex officio and shall have full voting power; and
- (5) The Faculty Senate of Kennesaw State University shall appoint one faculty member who shall have full voting power. The member appointed by the Faculty Senate shall serve for such term and most other qualifications as shall be fined in

The above names and addresses may be periodically changed as provided by law. At such time, the Articles of Incorporation and the Bylaws shall be deemed to be amended accordingly.

ARTICLE VII CORPORATE BYLAWS

The Board of Directors shall have power to adopt any bylaws regarding the corporation, not contrary to law or provisions of these Articles of Incorporation.
