### 1. Policy Purpose Statement

The purpose of this policy is to define Principal Investigator eligibility for Kennesaw State University Institutional Review Board submissions.

### 2. Definitions

**Principal Investigator (PI):** the individual primarily responsible for overseeing the preparation, conduct, and administration of human subjects research.

### 3. Policy

- 3.1. All human subjects research studies conducted at Kennesaw State University must designate an individual qualified to serve as the Principal Investigator (PI).
- 3.2. The Principal Investigator is ultimately responsible for the appropriate oversight and conduct of research. The PI may delegate certain responsibilities and functions of the research; however, he/she must maintain oversight and retain ultimate responsibility for the conduct of research and of those to whom responsibilities were delegated.
- 3.3. The PI must be sufficiently qualified by education, training, and experience to assume responsibility for the proper oversight and conduct of the research, including the protection of the rights, welfare, and safety of each human research participant.
- 3.4. Any individual who holds one of the following appointments at Kennesaw State University is eligible to serve as PI on IRB submissions:

3.6. Kennesaw State University students may serve as PI for their own research project and are responsible for submitting the IRB application. However, when a student is listed as the PI, a Faculty Sponsor must be listed on the submission.

3.6.1. For projects that do not meet the definition of human subjects research or where the IRB will rely on the review of an external IRB, students may serve as the PI for the purpose of submitting any documentation as outlined in policies related to determinations of human subjects research and reliance on external IRB review.
